

Nebraska Energy Federal Credit Union, (NEFCU) will award up to four (4) \$1,000 scholarships to NEFCU members who plan to attend an accredited Lineman or Wind & Solar school in Nebraska in 2026.

### **ELIGIBILITY**

1. Applicants must have an established membership with the credit union. **The account must be in their name and under their social security number.**
2. Members must be in good standing.
3. Previous recipients of the NEFCU scholarship are ineligible for future scholarship awards.
4. Immediate family members of NEFCU staff and volunteers are not eligible. Immediate family includes spouse, children, stepchildren, brothers, sisters, half-brothers, half-sisters, parents, stepparents, stepsiblings, adoptions.

### **ENTRY REQUIREMENTS** (Please submit **ONLY** the information requested)

1. Application must be **completed, signed, and submitted using this form ONLY.**
2. Applicants must provide official transcript reflecting a "C" average or higher through the end of the most recent semester.
3. One application per member.
4. Applicants must submit a typed personal essay as described within the application (maximum 600 words).

### **JUDGING**

1. Judging is completed by a panel of impartial professionals in post-secondary education who are not associated with the NEFCU Board, Management or Staff. Applications are submitted by number and judged anonymously.
2. Points will be awarded in each of the following areas:
  - Extracurricular Activities and Employment - 25 points
  - Personal Achievement – 25 points
  - Personal Essay - 50 points
  - Credit Union Service Usage – 20 points for each service used:  
*Services include Savings, Share Certificate, Checking, Loans, Credit Card, Debit Card*
3. **Application must be received by the credit union no later than January 31, 2026.**

### **ADMINISTRATIVE/AWARD PROCEDURES**

1. Winners must begin studies within 12 months of the date of written notification of the scholarship award.
2. Scholarship funds will be paid directly to the institution and the recipient.

### **AUTHORITY OF NEFCU**

NEFCU has the authority to amend any of the above rules to ensure fairness awarding the scholarships.
