

Nebraska Energy Federal Credit Union, (NEFCU) will award up to eighteen (18) \$1,000 scholarships to NEFCU members who plan to attend an accredited university, college, junior college, vocational or business school in 2019.

ELIGIBILITY

1. Applicants must have an established membership with the credit union. The account must be in their name and under their social security number. Member must be in good standing.
2. If selected, applicants must provide transcript reflecting a "C" average or higher through the end of the most recent semester.
3. All previous recipients of the NEFCU scholarship are ineligible for further scholarships from NEFCU.
4. Immediate family members of NEFCU staff and volunteers are not eligible. Immediate family includes: spouse, children, step-children, brothers, sisters, half-brothers, half-sisters, parents, stepparents, step-siblings, adoptions.

ENTRY REQUIREMENTS (Please submit ONLY the information requested!!)

1. Applicants must complete and sign an official scholarship application.
2. Applicants must submit a double spaced, typed personal essay as described within the application (maximum 600 words).

JUDGING

1. Judging is completed by a panel of impartial professionals in post-secondary education who are not associated with the NEFCU Board, Management or Staff.
2. Points will awarded in each of the following areas:
Personal Achievement (25 points)
Extracurricular Activities and Employment (25 points)
Personal Essay (50 points)
Credit Union Service Usage (5 points for each service used):
Share Account - Share Draft Account - Debit /ATM Card - Loan Product(s)
3. All applications must be received at the credit union no later than **5:00 p.m. on January 31, 2019.**

4. Winners will be notified by **March 29, 2019.**
5. All scholarship applications become the exclusive property of NEFCU.

ADMINISTRATIVE/AWARD PROCEDURES

1. Winners must begin studies within 12 months of the date of written notification of the scholarship award.
2. Winners must provide proof of acceptance or enrollment in one of the accredited university, college, junior college, vocational or business school.
3. Scholarship funds will be paid directly to the institution and the recipient within 30 days of the date of notification of enrollment.

AUTHORITY OF NEFCU
